RAFFLE TERMS AND CONDITIONS

1. Information on how to enter forms part of the terms and conditions of entry.
2. To be eligible to enter, participants must reside in Brisbane/Qld. This raffle is open to all AEIOU Foundation supporters, staff, directors, and the public.
3. Entrants must complete the form online via the AEIOU Foundation Raffle website by completing their contact details in the section provided.
4. Incomplete or incomprehensible entries will be ineligible. Complete entries will include at least a first name and surname, an email address and/or telephone number at a minimum.
5. Entrants are not restricted or limited to the number of raffle tickets which may be purchased.
6. Raffle tickets sales will commence on 6 April 2025 at 8.00am AEST and conclude on 6 April at 10:55am AEST. Raffle will be drawn on 6 April 2025 at 11.00am AEST.
7. Entrants need not be present to win. Prizes cannot be transferred or redeemed for cash.
8. The draw for the winner will take place at University of Queensland, St Lucia Campus on 6 April 2025 by electronic draw via "RaffleTix" platform.
9. In the draw for the winner, the 1st prize will be drawn first and the other prizes (if applicable) drawn in descending order of the prize number and value.
10. The AEIOU Foundation reserves the right to request winners to submit their ticket as proof of identity and purchase. Proof of identification of entry considered suitable for verification is at the discretion of the AEIOU Foundation.

If for any reason the raffle is not capable of running as planned, including (but not limited to) tampering or any other causes beyond the control of the AEIOU Foundation, which corrupt or affect the administration security, fairness or integrity or proper conduct of the raffle the AEIOU Foundation reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel terminate, modify or suspend the raffle subject to any direction given under state gaming regulations.
12. All winners will be notified by phone or email within 48 hours of the winners being drawn, and the winner's details will be published on the RaffleTix website within 24 hours of notification.

14. Prize values are the recommended retail value as provided by the supplier and are correct at the time of printing. All prize values are in Australian dollars.
