

# JURASSIC JAM 2024 RAFFLE

## TERMS AND CONDITIONS

1. Information on how to enter forms part of the terms and conditions of entry.
2. To be eligible to enter, participants must be 18 years or older and reside in Brisbane/Qld. This raffle is open to all AEIOU Foundation supporters, staff, directors, and the public.
3. Entrants must complete the form online via the AEIOU Foundation Raffle website by completing their contact details in the section provided.
4. Incomplete or incomprehensible entries will be ineligible. Complete entries will include at least a first name and surname, an email address and/or telephone number at a minimum.
5. Entrants are not restricted or limited to the number of raffle tickets which may be purchased.
6. Raffle tickets sales will commence on 20th August 2024 at 4.00pm AEST and conclude on 24th August at 8:00pm AEST. Raffle will be drawn on 24th August 2024 at 8.20pm AEST.
7. Entrants need not be present to win. Prizes cannot be transferred or redeemed for cash.
8. The draw for the winner will take place at The Triffid on 24th August 2024 by electronic draw via "RaffleTix" platform.
9. In the draw for the winner, the 1st prize will be drawn first and the other prizes (if applicable) drawn in descending order of the prize number and value.
10. The AEIOU Foundation reserves the right to request winners to submit their ticket as proof of identity and purchase. Proof of identification of entry considered suitable for verification is at the discretion of the AEIOU Foundation.
11. If for any reason the raffle is not capable of running as planned, including (but not limited to) tampering or any other causes beyond the control of the AEIOU Foundation, which corrupt or affect the administration security, fairness or integrity or proper conduct of the raffle the AEIOU Foundation reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel terminate, modify or suspend the raffle subject to any direction given under state gaming regulations.
12. All winners will be notified by phone or email within 48 hours of the winners being drawn, and the winner's details will be published on the RaffleTix website within 24 hours of notification.
